

COVID-19 ONSITE DIAGNOSTIC TESTING PROVIDERS

As of June 9, 2020

These "testers" and "labs" have agreed to offer full-facility onsite diagnostic testing to licensed ARF and RCFE residents and staff that serve DHS Housing for Health Enriched Residential Care clients and DMH Enriched Residential Care clients.

They have agreed to accept insurance as payment in full, and to bill a federal program for services delivered to uninsured people.

Appearance on this list does not imply endorsement of these providers. These providers are offered as a resource.

Facilities must decide which testing entity and laboratory best meets their needs.

Note that [current federal guidance](#) states that "antibody tests should not be used to diagnose acute COVID-19 infection."
